Notification

The 24th November, 1992

No. SO-78/CA.1986/S.5 & 7/92.—Whereas the Governor of Haryana identified the Zones for stone crushers,—*vide* Haryana Government Environment Department, notification No. S.O.94/C.A.1986/S. 5&7/92, dated the 4th August, 1992, in pursuance of Haryana Government, Environment Department, notification No. S.O.81/C.A.1986/S.5&7/92, dated the 9th June, 1992, in which it was *inter alia* directed that no stone crusher unit shall be allowed to operate within the limit of 1 kilometer from village abadi ;

And whereas it has been found that certain areas given in the Schedule of Haryana, Government, Environment Department notification No. S.O.94/C.A.1986/S. 5&7/92, dated the 4th August, 1992, are actually situated within the limit of 1 kilometer from village abadi, and it is necessary and expedient to exclude such areas from the said Schedule ;

And whereas the State Government is of the opinion that in view of the grave injury to the environment it is not expedient to provide an opportunity to invite objections against the proposed direction as required under sub-rule (3) of rule 4 of the Environment (Protection) Rules, 1986, in view of the principles as laid down by Supreme Court judgement, dated 15th May, 1992 ;

Now, therefore, in exercise of the powers conferred by section 5 of the Environment (Protection) Act, 1986, read with Government of India, Ministry of Environment and Forests Department of Environment, Forests and Wild Life, notification No. S.O. No.152(E), dated the 10th February, 1988, and in pursuance of the provisions of section 7 of the said Act and rule 4 of the Environment (Protection) Rules, 1986, and with reference to Haryana Government, Environment Department, notification No. S.O. 81/C.A. 1986/S.5&7/92, dated the 9th June, 1992, and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following amendment in the Haryana Government, Environment Department, notification No. S.O.94/C.A.1986/S. 5&7/92, dated the 4th August, 1992, namely :—
