Notification

The 7th December, 1992

**No. S.O. 152/C. A. 1986/S. 5 & 7/92.**—Whereas the Governor of Haryana issued orders,—*vide* Haryana Government, Environment Department notification No. S. O. 81/C. A. 1986/S. 5 & 7/92, dated the 9th June, 1992, that such stone crusher units which are in the prohibited limits as detailed in it will shift to zones as identified by the Government within six months from the date of issue of the said notification;

And whereas the Governor of Haryana identified the zones for stone crushers,—*vide* Haryana Government, Environment Department, notification No. S. O. 94/C. A. 1986/S. 5 & 7/92, dated the 4th August, 1992, as amended,—*vide* Haryana Government, Environment Department, notification No. S. O. 78/C. A. 198/S. 65 & 7/92, dated the 24th November, 1992, and whereas it was also ordered that all stone crushers which do not fulfil the siting parameters as stipulated in the Haryana Government, Environment Department, notification No. S. O. 81/C. A. 1986/S. 5 & 7/92, dated the 9th June, 1992, shall be shifted to any one of the zones identified in it by the 8th December, 1992;

And whereas certain stone crushers owners have purchased land in the new zones and have obtained "No Objection Certificate" from the Haryana State Pollution Control Board but they require time to complete their civil work and instal pollution control measures;

Now, therefore, in exercise of the powers conferred by section 5 of the Environment (Protection) Act, 1986, read with Government of India, Ministry of Environment and Forests, Department of Environment, Forests and Wild Life, Notification No. S. O. No. 152 (E), dated the 10th February, 1988, and in pursuance of the provisions of section 7 of the said Act and rule 4 of the Environment (Protection) Rules, 1986, and with reference to Haryana Government, Environment Department, notification No. S. O. 81/C. A. 1986/S. 5 & 7/92, dated the 9th June, 1992, and No. S. O. 94/C. A. 1986/S. 5 & 7/92, dated the 4th August, 1992, the Governor of Haryana hereby directs that the time limit for shifting of such existing stone crushers who have purchased land in the new crusher zones and have obtained "No Objection Certificate" from the Haryana State Pollution Control Board, shall be extended till the 15th February, 1993, to complete the civil work and installation of pollution control measures. No further extension will be given.
