

**5. इको क्लब की स्थापना**

पर्यावरण विभाग ने इको क्लब की व्यवस्था के अन्तर्गत 2850 स्कूलों में राष्ट्रीय हरित सेना क्लबों की स्थापना की है जिनको राज्य के 21 जिलों में बढ़ाकर 5250 कर दिया गया है।

**6. गुरुग्राम में पर्यावरण प्रशिक्षण संस्थान की स्थापना**

स्वर्ण जयंती पर्यावरण प्रशिक्षण संस्थान का मुख्य उद्देश्य सरकारी कर्मचारियों, औद्योगिक इकाईयों व समाज के विभिन्न वर्गों में पर्यावरणीय जागरूकता और ज्ञान पैदा करना है। यह स्कीम हरियाणा राज्य प्रदूषण नियन्त्रण बोर्ड पंचकूला के समन्वय से चलाई जा रही थी।

**7. जलवायु परिवर्तन डिविजन/सैल**

भारत के प्रधानमंत्री महोदय द्वारा जारी राष्ट्रीय मौसम परिवर्तन कार्य योजना (एन०ए०पी०पी०सी०सी०) में प्रस्तावित लक्ष्यों को लागू करने के लिए विभाग में मौसम बदलाव सैल का गठन वर्ष 2008 में किया गया था।

**8. हरियाणा राज्य जैव विविधता बोर्ड**

जैव विविधता अधिनियम, 2002 के तहत राज्य सरकार ने पर्यावरण विभाग में अधिसूचना दिनांक 14-11-2006 के द्वारा हरियाणा जैव विविधता बोर्ड का गठन किया। हरियाणा राज्य जैव विविधता बोर्ड को वन विभाग को स्थानान्तरित कर दिया गया और स्कीम रुक गई।

**Review of the Annual Administrative Report of the Environment & Climate Change Department, Haryana for the Year 2016-2017**

**ADMINISTRATION**

**No. DE&CCH-2018/2564.**— Enviorment Department is headed by Addiotional Chief Secretary/Principal Secretary, assisted by Head of Department i.e. Director, who is in the rank of Special Secretary to Government of Haryana, generally, the work of Government side is also looked after by him. He is assisted by one Joint Director and 3 Scientist Grade-1 for technical as well as day-to-day work. The various schemes for the control of Pollution and maintenance of clean environment are implemented by the Department.

**[1] Setting up of Head Quarter and Referral Laboratory Scheme:-**

The Enviorment Department has set up Referral Laboratory.

**[2] Setting up of Special Environment Courts**

The State Government has set up Two Special Environment Courts at Faridabad and Kurukshetra for disposal of cases pertaining to various environment Acts.

**[3] State Environment Impact Assessment Authority:**

The MoEF, GOI *vide* notification dated 21-08-2015 constituted a State Level Environment Appraisal Committee and State Level Environment Impact Assessment Authority for giving environmental clearance to Category 'B' Projects under EIA Notification dated 14-09-2006.

**[4] Environment Training Education and Awareness Programme:**

The Enviorment Department is making efforts to create awareness against the hazards of environment pollution by organizing seminars & workshops.

**[5] Setting up of Eco-Clubs:**

The Environment Department has established the National Green Corps under the Mechanism of Eco-Clubs in 2850 schools, which was raised upto 5250 Eco-Clubs in 21 District of the State.

**[6] Setting up of Environment Training Institute at Gurgaon.**

The main aim of Environmental Training Institute is to promote environmental awareness in Government employees, various section and Industrial sector of the society. The scheme was started by State Government in collaboration with HSPCB, Panchkula.

**[7] Creation of Climate Change Cell**

This scheme was started in the year 2008 for implementation of the missions as prescribed in the National Action Plan on Climate Change (NAPCC) released by the Hon'ble Prime Minister of India.

**[8] Haryana State Bio-Diversity Board**

In pursuance of Biological Diversity Act, 2002, State Government in the Environment Department *vide* Notification, dated 14-11-2006 had constituted Haryana State Biodiversity Board. The Board was transferred to Forest Department & the scheme of Bio-diversity strenghtning has been stopped.

**[9] Information in respect of Vigilance Department**

No vigilance inquiry has been conduct against any officer/official during the year 2016-17.
