ORDER

Jaipur, July 24, 2025

No. F.SEIAA(03)/Env./2022/

1. The Ministry of Environment, Forest and Climate Change, Government of India in exercise of the powers conferred by sub-section (3) of section 3 of the Environment Protection Act, 1986 and in pursuance of the Notification No. S.O. 1533(E) dated 14th September, 2006, has constituted the State Level Environment Impact Assessment Authority (SEIAA) and the State Level Expert Appraisal Committee (SEAC) to appraise and take decisions on the applications being submitted for grant of Environmental Clearance.
2. After careful consideration, it has been decided by the State Government to impose a one-time processing fee for the projects seeking Environmental Clearance (EC) from the State Level Environment Impact Assessment Authority, under the Environment Impact Assessment Notification No. S.O. 1533(E) dated 14th September, 2006 and its subsequent amendments in the following manner: -

(A) Construction Projects/Area Development Projects: -

(D) <u>Transfer EC, Extension of EC/TOR Validity, Revised EC, Amalgamation of Companies etc.</u>	Processing Fee (In Rs.)
For all Category of Projects: -	25,000

3. The above processing fee is exclusive of all other expenses to be incurred by the Project Proponent towards Public Hearing.

4. The processing fee is applicable to the following proposals: -

- i) All new projects or activities listed in the schedule of Environment Impact Assessment Notification, 2006 and its subsequent amendments.
- ii) Expansion and modernization of existing projects or activities listed in the schedule of Environment Impact Assessment Notification, 2006 and its subsequent amendments.

5. The one-time processing fee shall be non-refundable irrespective of whether the proposal qualifies for grant of Environmental Clearance or it is rejected at any stage of the appraisal process.

6. The Processing Fee shall be remitted by the applicants to the Government Treasury payable to the "Budget Head 8443-Civil Deposit, 00- Civil Deposit, 106-Personal Deposit, (00)-Personal Deposit,{00}-Personal Deposit in Account No.19236 and Office Id-112550 through NEFT/RTGS/IMPS/IFMS-e-Gras payment option in favour of Member Secretary, State Level Environment Impact Assessment Authority, Rajasthan. A copy of the transaction receipt shall be enclosed with the application submitted through PARIVESH Portal.

7. This order issues with the concurrence of Finance Department vide ID No. 102206594 dated 14.03.2023 and ID No. 102500330 dated 23.06.2025.

8. This Notification will come into force with immediate effect from the date of its notification and shall remain valid until further orders.
