The following Act of the Tamil Nadu Legislative Assembly received the assent of the Governor on the 1<sup>st</sup> March 2011 and is hereby published for general information :-

### ACT NO. 5 OF 2011

#### ***An Act further to amend the Tamil Nadu Marine Fishing Regulation (Amendment) Act, 1983.***

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Sixtysecond Year of the Republic of India as follows:-

1. (1) This Act may be called the Tamil Nadu Marine Fishing Regulation (Amendment) Act, 2011  
(2) It shall come into force on such date as the State Government may, by notification, appoint

2. In section 3 of the Tamil Nadu Marine Fishing Regulation (Amendment) Act, 1983 for clause(g), the following clause shall be substituted, namely:-

Amendment of section 3

(g) “mechanized fishing vessels” means a ship or boat fitted with mechanical means of propulsion having an engine of not less than twenty Horse Power but not more than one hundred and fifty Horse Power and measuring in length not less than ten metres and less than twenty metres, but does not include a deep sea fishing vessels, and a “ deep sea fishing vessels” means a ship or boat fitted with mechanical means of propulsion having an engine of more than one hundred and fifty Horse Power and measuring in length not less than twenty metres;”.
