hereby nominates, with effect from the 29th May, 1992, Ms. Annie Prasad as Member-Secretary of the National Commission for Women *vice* Ms. Uma Pillai and for that purpose makes the following amendments in the notification of the Government of India in the Ministry of Human Resource Development (Department of Women and Child Development) number S.O.100(E), dated the 31st January, 1992 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), dated the 31st January, 1992 namely:-

In the said notification,-
