**1. RECEIPT OF NOMINATIONS:**

Nomination from amongst the registered veterinarians of Haryana Veterinary Council may be filed in person or by registered post up to 19.05.2016 (Thursday) (9.00 am to 5.00 pm) in the office of the Returning Officer in Form-A which is available in the office of the Returning Officer and on website of Animal Husbandry & Dairying, Haryana at [www.pashudhanharyana.gov.in](http://www.pashudhanharyana.gov.in)

**2. SCRUTINY OF NOMINATIONS:**

It will be done on 20.05.2016 (Friday)

**3. WITHDRAWAL OF NOMINATIONS PAPERS:**

The application for withdrawal of nomination papers shall be entertained up to 24.05.2016 (Tuesday) (9.00 am to 5.00 pm)

**4. DECLARATION OF VALID NOMINATIONS:**

The names of valid nominees will be declared on 27.05.2016 (Friday) and they shall be informed by registered post under intimation to their proposers and seconders and a list of such candidates will be displayed in the office of the Returning Officer on 27.05.2016 (Friday) (9.00 am to 11.00 am) and on website of Animal Husbandry & Dairying, Haryana at [www.pashudhanharyana.gov.in](http://www.pashudhanharyana.gov.in)

**5. DESPATCH OF BALLOT PAPERS:**

The Ballot Papers shall be despatched to the electors/registered veterinarians by registered letters from 09.06.2016 (Thursday).

**6. RECEIPT OF MARKED BALLOT PAPERS:**

Duly marked Ballot Papers should reach the office of the Returning Officers latest by 29.06.2016 (Wednesday) (up to 5.00 pm). Ballot Papers received after 5.00 pm will be rejected.

**7. COUNTING OF VOTES:**

Counting of votes will commence at 9.00 am on 01.07.2016 (Friday) in the office of Returning Officer.

**8. DECLARATION OF RESULTS:**

Results will be declared immediately after the counting is over on 01.07.2016 (Friday).

Nominations from the eligible candidates are hereby invited for election of 4 (Four) members to the Haryana Veterinary Council in the format (Form A). Nominations papers should be delivered in person or by registered post to the Returning Officer, Dr.G.S. Jakhar, Director General, Animal Husbandry & Dairying, Haryana, Pashudhan Bhawan, Sector 2, Panchkula on or before the appointed date & time.
