- (7) Goods and Services Tax Inspector (as per provisions of section 3(g) of the DGST Act 2017)



Concurrently, the abovementioned categories of officer(s) as appointed under Section 3 read with sub-section (1) of Section 4 of the Delhi Goods and Services Tax Act, 2017 shall perform statuary and other functions under the DGST Act.
