No. F 23-5/2011/35 In exercise of the powers conferred by sub-section (1) of section 43 of the Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009 (No. 27 of 2009), the State Government, with the approval of the Central Government, hereby, makes the following rules, namely :-

### RULES

#### 1. Short title and commencement.-

- (1) These rules may be called the Prevention and Control of Infectious and Contagious Diseases in Animals (Check Post and quarantine camp, manner of inspection.etc.) Rules, 2015.
- (2) They shall come into force from the date of their publication in the Madhya Pradesh Gazette.

#### 2. Definitions.- (1) In these rules unless the context otherwise requires,-

- (a) "Act" means the Prevention and Control of Infectious and Contagious Diseases in Animals Act, 2009 (No. 27 of 2009);
- (b) "Form" means forms appended to these rules.
- (c) "Section" means section of the Act;

(2) Words and expressions used but not defined in these rules shall have the same meaning as assigned to them in the Act.

#### 3. The manner of inspection and the period of detention at quarantine camp and check post.-

- (1) In order to ascertain whether the animal is infected with any of the scheduled notified disease, the animal stopped at the check post or detained in the quarantine camp shall be inspected by the person in charge of check post or quarantine camp for the following, namely :-
  - (i) movement and gait;
  - (ii) dull, depressed, normal or excited behaviour;
  - (iii) increase in body temperature;
  - (iv) ulcer in the mouth, feet or udder;
  - (v) excessive lacrimation, nasal or vaginal discharge;
  - (vi) sweating and shivering;
  - (vii) dryness of the skin, alopecia, skin rashes;
  - (viii) weakness;
  - (ix) bleeding through natural openings;
  - (x) swelling in dewlap region or any other part of the body;

- (2) The person in charge of check post or quarantine station shall also collect the necessary samples for laboratory examination, if required.

(3) The person in charge of check post may detain animals at the check post for a period not exceeding twelve hours for the purpose of inspection, compulsory vaccination and identification/marketing etc. the owner of the animals vaccinated shall be given a vaccination certificate at the check post as required by section 9 of the Act.

(4) After careful examination of the animal, the officer in charge shall either allow entry of the animal to the notified control area or free area by issuing an entry permit in Form A appended to these rules or transport the animals to the quarantine camp.

(5) Charges for examining animal shall be as follows.-(i) for examination (Rs. 10/- for large animals and Rs.5/- for small animals), vaccination (Rs. 5/- for large animals and Rs.2/- for small animals) and ear tagging or any suitable method of identification of animal (Rs.10/- for large and small animals) shall be borne by the animal owner.

(ii) other expenses at check post shall also be borne by the animal owner.

**4. Animal to be detained by the officer-in-charge of quarantine camp.-**

(1) The officer-in-charge of the quarantine camp shall detain the following animals:-

- (i) which are suffering from any scheduled notified disease; or
- (ii) which have come into contact with or have been kept in the proximity of animal infected with a scheduled notified disease; or
- (iii) transported by the incharge of check post as mentioned in sub-rule (4) of rule 3; or
- (iv) any species of animals affected by any Scheduled disease as may be notified at the time of exit from the controlled area.

shall be subjected to a quarantine of 14 days in a quarantine camp.

(2) the officer-in-charge of quarantine camp shall give an acknowledgement to the animal owner for the animals detained in the quarantine camp in Form B appended to these rules.

(3) During quarantine, the animals shall be identified by ear-tagging or any other suitable method of identification bearing unique number, animals shall be examined regularly for any scheduled disease. Animal shall be vaccinated against the scheduled disease and provided with veterinary treatment, if required, if animals are vaccinated, the owner of the animal shall be provided with a vaccination certificate as required in section 9 of the Act.

(4) (i) The charges for examination (Rs. 10/- for large animals and Rs.5/- for small animals), vaccination (Rs. 5/- for large animals and Rs.2/- for small animals) and ear tagging or any suitable method of identification of animal (Rs.10/- for large and small animals) shall be borne by the animal owner.

(ii) other expenses at quarantine camp shall also be borne by the animal owner;

(5) After successful quarantine, the officer-in-charge of quarantine camp shall release the animals to the animal owner and also grant the quarantine Release Permit as per Form-C appended to these rules under his signature. Form-C shall also serve as Entry permit as required in sub-section (2) of section 15 of the Act.

#### 5. Jurisdiction.-

If any question or any doubt arises in relation to the interpretation of these rules, the matter shall be referred to the Director of Animal Husbandry, Government of Madhya Pradesh whose decision thereon shall be final and binding.
