Whereas, the appropriate Government has proposed for Construction of connectivity from Dakshin Marg to P.R 4 Road U.T./Punjab Boundary as per the approved Master Plan in the Union Territory of Chandigarh, by acquiring land for the said purpose.

And whereas in view of provision of Section 4(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 and Rule 3(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement (Social Impact Assessment and Consent) Rules, 2014, the Social Impact Assessment is required to be carried out in consultation with the concerned Gram Panchayat and Municipal Corporation in the affected areas. The proposed acquisition of aforesaid road would entail about 18 acres of land. These lands shall be acquired from Village Dhanas H.B. No. 15 (approx. 5.57 acre) and Village Dadu Majra H.B. No. 14 (approx. 12.23 acre), thus affected area shall be of Village Dhanas and Dadu Majra Tehsil, U.T., Chandigarh.

The main objectives of Social Impact Assessment would be to:-

- I. Assess that if the proposed acquisition serves public purpose;
- II. Estimate the number of affected families and number of families among them likely to be displaced;
- III. Understand the extent of land public and private, houses, settlement and other common properties which are likely to be affected by the proposed acquisition;
- IV. Understand extent of land acquired which would be bare minimum needed for the project;
- V. Analyse whether any alternate place would be feasible for the said purpose ;
- VI. Study the social impacts, nature and cost of addressing them and impact of these cost on the overall cost of the project vis-a-vis the benefits of the project.

It is hereby notified that the proposed acquisition of land under the proposed project falls under the provision of section 2(1)-(e) i.e. **project for planned development** and the entire Social Impact Assessment shall be carried out in consultation with Panchayat and land owners.

The Social Impact Assessment (SIA) shall commence from the date of issuance of this Notification, which shall be completed within 6 months. The important output of the SIA shall include Social Impact Assessment report and Social Impact Management Plan, along with the disclosure as prescribed under section 6 of the said Act. The Social Impact Assessment shall be carried out by the Punjab University, Chandigarh which has been notified as Social Impact Assessment (SIA) Unit as per the provisions of Rule 4(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement (Social Impact Assessment and Consent) Rules, 2014.
