NOTIFICATION

Jaipur, July 1, 1989

No. F. 7(1) Sansad/89—In exercise of the powers conferred by section 11 read with sub-section (2) of section 4-A of the Rajasthan Legislative Assembly (Officers and Members Emoluments and Pension) Act, 1956 (Rajasthan Act No. 6 of 1957), the State Government hereby makes the following rules, namely :—

The Rajasthan Legislative Assembly [#]Ex-Members (Free Transit by Road Transport Service) Rules, 1989 & Amendment Rule 2019

1. Short title and commencement.—(1) These rules may be called the Rajasthan Legislative Assembly [#]Ex-Members and family Pensioner (Free Transit by Road Transport Service) Rules, 1989 & Amendment Rules 2019.

(2) They shall be deemed to have come into force on 1st day April, 2019.

2 Definition.—In these rules, unless the context otherwise requires:—

- (a) “Act” means the Rajasthan Legislative Assembly (Officers and Members Emoluments and Pension) Act, 1956;
- (b) “Pass” means the “Identity-Cum-Road Journey Pass” issued under rule 3;
- (c) *[#]“Ex-Member” means a person who is a recipient of or is entitled to pension under section 4-A of the Act;
- [@](cc) Family Pensioner means the spouse of a deceased Ex Member and who is entitled to receive Family Pension under Section 4c of the Act.
- (d) “Principal Secretary” means the Principal Secretary, Rajasthan Legislative Assembly and includes any officer of the said Assembly and specially empowered by the Speaker to perform the functions of the Secretary under these rules;
- (e) “Service Bus” includes all kind of buses run by Rajasthan State Road Transport Corporation or buses run on contract basis;

- (f) "State Roadways" means the Rajasthan State Road Transport Corporation Service.

3 ~~Ex-Member~~ and Family Pensioner entitled to travel on passes.

—Subject to the provisions of these rules, every *Ex-member and Family pensioner shall be provided by the Principal Secretary with Two free non-transferable passes in the form given in Appendix-AA which shall entitle him and any other person accompanying him to travel at any time free of charge by the service buses of the State Roadways and on any route on which the State Roadways operate.

4 [@]Ex-member entitled to travel on passes— Be each year, every ex-members shall be supplied by the secretary Four books containing [@]ex-member and his attendant's Bus Journey Form's with the foils in Appendix-BB. Each book shall contain 50 serial numbers and until one book is exhausted the ex-member shall not use the another book and at the end of every year the ex-member shall return the books to the Secretary and until the books are returned as aforesaid the Secretary shall not issue new book for the next year.

"4A Family Pensioner Entitled to travel on Passes:- In each year, every family pensioner shall be supplied by the Principal secretary two books containing family Pensioner's and his attendant's Bus Journey Form's with the foils in Appendix-BB. Each book shall contain 50 serial numbers and until one book is exhausted the family pensioner shall not use the another book and at the end of every year the family pensioner shall return the books to the Principal Secretary and until the books are returned as aforesaid, the Secretary shall not issue new book for the next year."

5 Procedure for journey.—(1) On the commencement of a journey the Ex-member or Family Pensioner as the case may be shall fill in the form and the foils thereof and hand over the form to the conductor of the bus. The conductor shall thereon fill in the amount of fare chargeable for the journey on the foil with the Ex-member or Family Pensioner as the case may be. A separate form shall be used for each journey by different buses.

(2) An Ex-member or Family Pensioner as the case may be shall, on demand by the conductor or any other officer of the State Roadways duly authorised in this behalf, produce the pass for inspection.

(3) An Ex-member or Family Pensioner as the case may be wishing to reserve his seat may do so on payment of charges for reservation.

6 Permissible luggage.—An Ex-member/Family Pensioner shall be entitled to carry such luggage free of charge as is permissible to a passenger for the class in which the Ex-member/Family Pensioner travels and Ex-member/Family Pensioner shall have to pay for the excess luggage, if any, on the rates fixed in that behalf by the State Roadways.

7. Period of validity of the pass.—(1) The pass granted under these rules shall be valid only during the period the holder continues [to be an Ex-member] under the provisions of section 4-A of the Act and the holder shall return the pass to the Secretary as soon as he ceases to be an Ex-member.

(2) The Pass granted under these rules shall be valid only during the Provisions of section 4-C of the Act and the holder shall return the Pass to the Secretary as soon as he/she ceases to be a Family Pensioner.

8 Report of loss of pass, etc.—When an Ex-member or Family Pensioner as the case may be loses his Pass/Free Journey Form Book, he shall immediately report the fact of such loss to the Principal Secretary Rajasthan Legislative Assembly and Executive Director (Traffic) Rajasthan State Road Transport Corporation. On receipt of such report, a fresh Pass/Free Journey Form Book, as the case may be, may be issued by the Secretary to the Ex-member or Family Pensioner as the case may be on his paying rupees fifty in the case of the pass and rupees fifty in the case of each Free Journey Form Book. If the pass/free journey form book is subsequently found, it shall be surrendered to the Secretary.

9 Provision for payment of amount due on account of the journey.—The Principal Secretary shall arrange to make the payment from the budget of the Legislative Assembly the amount due on account of the journey undertaken by the Ex-member/Family Pensioner, as determined on the basis of the Ex-member's/Family Pensioners Bus Journey Forms (duplicate foils) sent by the State Roadways for payment.

1. The Ex-member/family Pension to whom this pass is issued is responsible for its safe custody.
2. In case of loss, matter shall immediately be reported to the Principal Secretary, Rajasthan Legislative Assembly and the General Manager, Rajasthan State Roadways.
3. This pass shall be surrendered in the event of cessation of pension under section 4-A @or Cessation of Family Pension under section 4-C of the Act.
4. A journey form containing details of journey performed under this pass shall be filled in and handed over to the Bus Conductor before a journey begins.
5. This pass is issued subject to the provisions of section 4-A @or 4E of Rajasthan Legislative Assembly (Officers and Members Emoluments and Pension) Act, 1956 and rules made there under section 4-A of the said Act and can be used subject to availability of accommodation in the bus by which the journey is intended to be undertaken. 6. This pass shall be treated as a ticket for travel, subject to the same rules and conditions as govern a ticket in so far as they are not repugnant to the rules made under the Rajasthan Legislative Assembly (Officers and Members Emoluments and Pension) Act, 1956.
