## **MADHYA PRADESH PANCHAYAT AND RURAL DEVELOP- MENT DEPARTMENT CLASS IV SERVICE RECRUITMENT RULES, 1992**

*Noti. No. 15854-1309-XXII-D-2-Estt-92, dated 22-10-1992, Pub. in M.P. Rajpatra, Pt. IV (Ga), dated 13-11-1992, p. 375.-In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Madhya Pradesh hereby makes the following rules regulating the method and field of recruitment to the Madhya Pradesh Panchayat and Rural Development Department Class IV Service, namely:-*

**1. Short title.**-These rules may be called the Madhya Pradesh Panchayat and Rural Development Department Class IV Service Recruitment Rules, 1992.

**2. Application.**-These rules shall apply to every member of the service in respect of the posts specified in column (1) of the Schedule appended to these rules.

**3. Classification and Scales of Pay etc.**-The number of posts or their classification, the scales of pay attached thereto, the method of recruitment to the posts, age limit and other matters relating to the said posts shall be as specified in the Schedule.

**4. Saving.**-Nothing in these rules shall affect reservation and other conditions required to be provided for the Scheduled Castes and Scheduled Tribes, Ex-servicemen, Compassionate appointment of a member of the family of a Government servant who has died in harness and handicapped persons in accordance with the orders issued by the State Government from time to time in this regard.
