Rajpatra (Asadharan), dated 19-7-2001, p. 864.-In exercise of the powers conferred by Section 17 of the Child Labour (Prohibition & Regulation) Act, 1986 (No. 61 of 1986), the State Government hereby appoints all Gram Sabhas constituted under Section 5-A of the Madhya Pradesh Panchayat Raj E�am Gram Swaraj Adhiniyam, 1993 (No. 1 of 1994) as Inspectors within their respective jurisdictions as Inspector for the purpose of Section 17 of the said Act.

Notfn. No. F. 2-3-2010-VII-6-692(A), dated 4-5-2011, Pub. in M.P. Rajpatra, Pt. I, dated 27-5-2011, p. 1781.-In exercise of the powers conferred by sub-section (1) of Section 24 of the M. P. Land Revenue Code, 1959 (No. 20 of 1959) and in supersession of this department's Notification No. F. 2-2-VII S-8-2001, dated the 26th January, 2001 the State Government hereby confer the following powers upon all the Gram Sabhas constituted under the Madhya Pradesh Panchayat Raj Avam Gram Swaraj Adhiniyam, 1993 (No. 1 of 1994), within their respective jurisdictions, namely:—
