## MINISTRY OF HOME AFFAIRS

New Delhi, the 19th September, 1993

G.S.R. 485.—In exercise of the powers conferred by section 139 of the National Security Guard Act, 1986 (47 of 1986), the Central Government hereby makes the following rules regulating the method of recruitment to certain Group-'A' posts in the National Security Guard, Ministry of Home Affairs, namely :—

- Short title and Commencement.—(1) These rules may be called the National Security Guard (Group-'A' posts) Recruitment Rules, 1993.  
(2) They shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and scale of pay.—The number of said posts their classification and the scales of pay attached thereto, shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications etc.—The method of recruitment age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Schedule.

4. Initial constitution.—Officers on deputation in the National Security Guard, before the commencement of these rules, shall be deemed to have been appointed in accordance with the provisions of these rules.

5. Maintenance.—Subject to the initial constitution every post, presently unfilled and every vacancy that may arise after the commencement of these rules, shall be filled in accordance with the provisions of these rules.

- Disqualification.—(1) No person,  
(a) who has entered into or contracted a marriage with a person having a spouse living, or  
(b) who, having a spouse living, has entered into or contracted a marriage with any person.

shall be eligible for appointment to any of the said posts :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

7. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it

may by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.


8. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
