

***The Rajasthan Municipalities (Observance of Holidays and Regulating Hours of Work) Rules, 1961***

***Published vide Notification No. F. 8(176) LSG/61, dated 9-2-1962, published in Rajasthan Gazette, Part 4-C, dated 26-4-1962***

In exercise of the powers conferred by section 297 of the Rajasthan Municipalities Act, 1959 (Act No. 38 of 1959), the State Government hereby makes the following rules, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Municipalities (Observance of Holidays and Regulating Hours of Work) Rules, 1961.
- (2) These rules shall come into force after one month from the date of their publication in the Official Gazette.
2. **Observance of holidays.**- (1) The offices and institutions under the control of the Municipalities shall observe only such public and local holidays as are observed or are duly declared by the Government from time to time in respect of Government offices.
- (2) No Municipality or institution under its control shall observe holidays other than those declared for Government offices and institutions without the previous sanction of the State Government.

Provided that in case of the death of the members, ex-members, office bearers of the Local Body, Local festivals, fairs organised by the Local Body and other local institutions, exhibitions, the President/Chairman of Municipal Board or the Municipal Council, as the case may be, may declare holiday on such day:

Provided further that the member of such holidays shall not exceed 3 days in a calendar year.

3. **Hours of work.**- The working hours of the offices of the Municipalities shall be such as may be prescribed by Government for Government offices in the Municipal Area.
4. Notwithstanding anything contained in any of the provisions of the above Rules the State Government shall have power to relax or modify the rules for a particular Board or in general, as the case may be.

**Sub.- Observance of Holidays.**

Attention is invited to the Rajasthan municipalities (Observance of Holidays and Regulating Hours of Work) rules, 1961 issued under this Department Notification No. F. 8(176) LSG/61 dated 9- 2-1962 laying down that the offices and institutions under the control of the Municipalities shall observe only such public and local holidays as are observed or are duly declared by the Government from time to time in respect of Government offices.

The Governor has been pleased to order (Vide Government of Rajasthan General Administration Department 'A' Order No. F. 1(18)/GA/Gr. 11/62 dated 11-12-1962) that with immediate effect all offices and courts (except those under the Rajasthan Court) throughout Rajasthan, shall observe office hours from 10 A.M. to 5.30 P. M. with half an hour break for lunch between 1.30 P. M. to 2.00 P. M. and second Saturday of each month will be observed a full holiday till further orders.

It has come to the notice of the Government that some of the Municipalities are not following the aforesaid instructions.

It is requested that action may be taken in compliance with Government decision with immediate effect.
