ORDINANCE

Imphal, the 20th February, 1995

No. 2 of 1995

No. VC.CAU.14(ESTABLIS)/93: Whereas the approved Expenditure Finance Committee Memo along with addendum in respect of the sanction of the Central Agricultural University scheme under the VIIIth Five-Year Plan, as communicated by the Joint Secretary, Department of Agricultural Research and Education and Secretary, Indian Council of Agricultural Research vide their letter number I(2)/92-PI and M(Part III), dated the 13th October, 1993, provides for the establishment of a College of the Central Agricultural University, Imphal.

And whereas the Government of Mizoram has transferred the land measuring 168.61 acres to the Central Agricultural University at Selesih for establishment of the College of Veterinary Science vide notification number D.11011/1/92-AH&D, dated the 1st November, 1994.

And whereas the Government of India in the Department of Agricultural Research and Education/Indian Council of Agricultural Research (ICAR) has approved the making of the first Ordinance regarding the establishment and management of the College of Veterinary Science at Selesih in Mizoram vide its letter number 42-1/94-Edn. IV, dated 31st January, 1995.

Now, therefore, in exercise of the powers conferred by sub-section (2) read with clause (k), (o) and (2) of sub-section (1) of section 27 of the Central Agricultural University Act, 1992 (40 of 1992), and with the previous approval of the Central Government, I, the Vice-Chancellor of the Central Agricultural University, Imphal, do

hereby make the first Ordinance and notify the following provisions for the establishment and management of the College of Veterinary Science, at Selesih in Mizoram, namely:

1. There shall be a College of Veterinary Science hereinafter referred to as the said College at Selesih, Mizoram which shall be a constituent College of Central Agricultural University, Imphal.
2. The said college shall be managed as per the Act, Statutes and Ordinances of the Central Agricultural University and the regulations made by the authorities of the Central Agricultural University.
3. The said College shall have Bachelor of Veterinary Sciences and Animal Husbandry (B.V.Sc. and A.H.) degree Programme as prescribed by the Veterinary Council of India.
4. The said College initially shall have an intake capacity of 22 students, including those to be admitted as per the provisions/nominations made by Veterinary Council of India/ICAR and the number of students may be increased to a maximum of 40.
5. The said College shall have seventeen Departments specified in column (1) of the Table below and shall consist of the Professor, Associate Professor and Assistant Professors specified in the corresponding entry in column (2) of the said Table.
