ORDINANCE

Imphal, the 30th August, 1994

No. 5 of 1994

No. VC CAU/14(ESTABLIS)/93: Whereas the sanction of the Central Agricultural University scheme under the VIIIth Five Year Plan, as communicated by the Joint Secretary, Department of Agricultural Research and Education and Secretary, Indian Council of Agricultural Research vide letter number 1(2)/92-PI&M(Part-III) dated the 13th October, 1993 provides for the establishment of the Central Agricultural University for North-Eastern Region with headquarters at Imphal (Manipur) having office of the Vice-Chancellor, Directorates of Instruction, Research and Extension Education, etc. and with College of Agriculture (Manipur), College of Veterinary Sciences (Mizoram), College of Agricultural Engineering and Post-Harvest Technology (Sikkim), College of Horticulture and Forestry (Arunachal Pradesh), College of Fisheries (Tripura), College of Post-Graduate Studies and College of Home Science (Meghalaya) in the States of the North-Eastern Region as mentioned in respective parentheses:

And whereas the aforesaid sanction also provides for creation and filling of the Academic positions, such as the Director of Instruction, Director of Research and Director of Extension Education, Deans of the concerned Colleges and of Professors, Associate Professors and Assistant Professors and their equivalent academic positions in the University Grants Commission grades:

And whereas the Government of India in the Department of Agricultural Research has approved the issue/making of an Ordinance prescribing the academic and other

qualifications for the various academic and scientific positions for the Central Agricultural University vide letter No. 42(1)/94-Edn/IV dated 8th August, 1994.

Now, therefore, in exercise of the powers conferred by sub-section (2) of read with clauses (n) and (q) of sub-section (1) of section 27 of the Central Agricultural University Act, 1992 (40 of 1992) and with the previous approval of the Central Government, I, the Vice-Chancellor of the Central Agricultural University, Imphal, do hereby prescribe the following academic and other qualifications, for the purposes of appointment to various teaching/academic positions of the University, as mentioned against respective positions.

(i) Master's degree in the concerned discipline (relaxable in case of Extension Education subject) followed by a doctorate degree in the concerned subject.

(ii) Ten years teaching/research/extension education experience in the concerned subject out of which at least 5 years should be in the rank of Associate Professor or equivalent in the Agricultural University/National Research System.

(iii) Outstanding contribution as evidenced by published works in reputed journals (relaxable in case of Krishi Vigyan Kendra/extension education positions).

Desirable:

Adequate experience of teaching and guiding Post-Graduate students.

- (ii) Five years experience of teaching/research/extension education in the rank of Assistant Professor or equivalent.
- (iii) Contribution as evidenced by publications in reputed journals/books.

7. Assistant Professor Essential:

- (i) Bachelor's degree in the concerned discipline (relaxable in case of Extension Education) followed by a Master's degree with 55% marks at least in the concerned subject and a consistent good academic record.
- (ii) Qualified in the National Eligibility Test examination of University Grants Commission/Council of Scientific and Industrial Research/Agriculture Scientists Recruitment Board (relaxable in case candidates with National Eligibility Test is not available).
