ORDINANCE

Imphal, the 23rd June, 1994

No. 2 of 1994

No. VCCAU/14(ESTABLIS)/93: Whereas the Government of India in the Department of Agricultural Research and Education/Indian Council of Agricultural Research has approved to make an ordinance regarding the admission to and enrolment of students to Bachelor of Science (Agriculture) B.Sc. (Agri.) Course in the Central Agricultural University, Imphal vide letter No. F 1-24(1)/94-ICAR/Edn. II dated the 14th June, 1994.

Now, therefore, in exercise of the powers conferred by sub-section (2) read with clause (a) of sub-section (1) of section 27 of the Central Agricultural University Act, 1992 (40 of 1992), and with the previous approval of the Central Government, as aforesaid, I, the Vice-Chancellor of the Central Agricultural University, Imphal, do hereby make this first Ordinance and notify that the admission of students to the 1st year of B.Sc. (Agri.) in the College of Agriculture, Imphal shall be allotted in the following manner to the States of North-Eastern Region as defined in the said Act:

1. Arunachal Pradesh	6
2. Manipur	10
3. Meghalaya	8
4. Mizoram	3
5. Sikkim	3
6. Tripura	10

Every candidate seeking admission to the B.Sc. (Agri.) Course shall be a domicile in the concerned State and of not less than 17 years of age as on the 31st day of December of the academic year to which the admission is sought for. The candidates shall be selected by the respective State Governments on the basis of merit of marks obtained in the qualifying examination and keeping in view of the reservation policies of the concerned States. The minimum qualification for admission shall be 55 per cent of marks on aggregate at 10+2 level with English, Physics, Chemistry and Biology/Mathematics. A weightage of 5% marks shall be given to the candidates in service with at least 3 (three) years of regular service in any Government Organisation and to the Scheduled Castes/Scheduled Tribes candidates.
