In pursuance of the provisions of clause (3) of Article 348 of the Constitution, the Governor is pleased to order the publication of the following English translation of notification no. 2(2)/75-Revenue-I, dated April 2, 1975 :

No. 2(2)/75-Revenue-I

April 2, 1975

In exercise of the powers under sub-section (1) of section 44 of the Uttar Pradesh Imposition of Ceiling on Land Holdings Act, 1961 (U. P. Act no. I of 1961), read with section 21 of the U. P. General Clauses Act, 1904 (U. P. Act no. I of 1904), the Governor is pleased to make the following Rules, after their previous publication under Government notification no. 2(2)/75-Revenue-I, dated February 26, 1975, with a view to amending the Uttar Pradesh Imposition of Ceiling on Land Holdings Rules, 1961 :

The Uttar Pradesh Imposition of Ceiling on Land Holdings (Second Amendment) Rules, 1975

1. Short title and commencement.—(i) These rules may be called the Uttar Pradesh Imposition of Ceiling on Land Holdings (Second Amendment) Rules, 1975.

(ii) They shall come into force with effect from the date of their publication in the *Gazette*.

2. Omission of rule 3.—Rule 3 of the Uttar Pradesh Imposition of Ceiling on Land Holdings Rules, 1961 (hereinafter referred to as the said Rules), shall be omitted.

3. Amendment of rule 4.—In the said rules, for sub-rules (5) and (6) of rule 4, set out in column 1, the sub-rule as set out in column 2 shall be substituted :

COLUMN 1

Existing rule

(5) Land held by a Goshala registered under the U. P. Goshala Adhiniyam, 1964, and utilised for grazing or growing fodder crop, shall be exempt under clause (g) of section 6 to the extent of one hectare of irrigated land for every ten heads of cattle including calves maintained by the Goshala concerned.

(6) Land let out after the enforcement of the Act to a Government lessee for reclamation and cultivation or for cultivation of jute shall be exempt under clause (h) of section 6.

4. Amendment of rule 8.—In the said rules, for rule 8, set out in column 1, the rules as set out in column 2 shall be substituted :

8. As soon as may be after the expiry of 30 days from the date of publication of the general notice in C. L. H. Form 1 in the official *Gazette*, the Prescribed Authority shall cause to be served upon every tenure-holder, who has failed to submit the statement in C. L. H. Form 2, or has submitted an incomplete or incorrect statement, a notice in C. L. H. Form 4 together with a copy of the statement in C. L. H. Form 3, prepared under rule 6 calling upon him to show cause within a period of 15 days from the date of service of the notice why the aforesaid statement be not taken as correct :

Provided, however that in the case of a tenure-holder who is a member of the Armed Forces (Military, Naval or Air-Force) of the Union of India the period within which he will be called upon to show cause why the statement in C. L. H. Form 3 be not taken as correct, shall be ninety days from the date of service of the notice in C. L. H. Form 4.

COLUMN 2

(5) Land held by a Goshala referred to in clause (g) of section 6 shall be exempt under that clause to the extent of one hectare of irrigated land for every ten heads of cattle including calves maintained by the Goshala concerned.

8. As soon as may be, after the expiry of thirty days from the date of publication of the general notice in C. L. H. Form 1 in the official *Gazette*, the Prescribed Authority shall cause to be served upon every tenure-holder, who has failed to submit the statement in C. L. H. Form 2 or has submitted an incomplete or incorrect statement, a notice in C. L. H. Form 4 together with a copy of the statement in C. L. H. Form 3, prepared under rule 6 calling upon him to show cause within a period of fifteen days from the date of service of the notice why the aforesaid statement be not taken as correct :

Provided that where the statement in C. L. H. Form 3 also includes land ostensibly held in the name of any other person, the prescribed authority shall cause to be served upon such other person a notice in C. L. H. Form 4 together with a copy of the statement in C. L. H. Form 3 calling upon him to show cause within a period of fifteen days from the date of service

of the notice why the aforesaid statement be not taken as correct :

Provided further that in the case of a tenure-holder who is a member of the Armed Forces (Military, Naval or Air Force) of the Union of India, the period within which he will be called upon to show cause why the statement in C. L. H. Form 3 be not taken as correct, shall be ninety days from the date of service of the notice in C. L. H. Form 4.

5. **Insertion of new rule 11-A.**—In the said rules, after rule 11, the following rule shall be inserted, namely :

"11-A. The provisions of rules 10 and 11 shall *mutatis mutandis* apply in the case of holdings held by a firm, co-operative society or other society or association of persons other than a public company."

6. **Amendment of C. L. H. Form 2.**—In the said rules, for C. L. H. Form 2 including annexures, set out in column 1, the C. L. H. Form 2 including annexures set out in column 2 shall be substituted :
