In compliance of Explanation (i) of Section 69 of The Punjab Co-operative Societies (Amendment) Act, 2021 issued by Punjab Government Gazette Notification dated 26.04.2021, it is notified that the following officers of the Cooperative Department shall exercise the powers of Revision under section 69 of the above aforesaid act:-

S.No.	Officers by whom Appeal has been heard under Section 68 of The Punjab Cooperative Societies Act 1961.	Officers before whom the revision under Section 69 of The Punjab Cooperative Societies Act 1961 may be filed.
1	Assistant Registrar, Co-operative Societies, Punjab	Deputy Registrar, Co-operative Societies, Punjab of concerned district.
2	Deputy Registrar, Co-operative Societies, Punjab	Joint Registrar, Co-operative Societies, Punjab of concerned division.
3	Joint Registrar, Co-operative Societies, Punjab	Registrar, Co-operative Societies, Punjab. *Registrar Co-operative Societies, Punjab may hear it on his own or assign it to any Additional Registrar, Co-operative Societies, Punjab.
4	Additional Registrar, Co-operative Societies, Punjab	Registrar, Co-operative Societies, Punjab.

Note :- If Appeal under Section 68 of the Punjab Co-operative Societies Act, 1961 relates to any of the Apex Cooperative Institutions and is decided by any of the Deputy Registrar, Co-operative Societies, Punjab posted at Head Office, Chandigarh then the Revision under Section 69 of the Punjab Co-operative Societies Act, 1961 may be filed before the Registrar who may decide it on his own or assign it to any officer not below the rank of Joint Registrar, Co-operative Societies, Punjab.

2. If at any point of time the officers mentioned above before whom the revision under Section 69 of the Punjab Co-operative Societies Act, 1961 actually lies and that seat is vacant, then the petitioner may file it before the officer of higher rank who may decide the revision petition on his own or assign it to any other officers of the same rank under his jurisdiction, before whom the revision actual lies.
