**NOTIFICATION**

Whereas the draft of certain Rules which the Administration of Daman & Diu propose to make in exercise of powers conferred under Section 211 of Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) and as amended by Act 54 of 1994 were published as required by sub section (1) of Section 212 of the said Act in the Gazette of Daman & Diu Administration, Extraordinary Series No 09 dated 04/07/2006, inviting objections and suggestions from all persons likely to be affected thereby before the expiry of fifteen days from the date on which the copies of the Gazette, in which the said notification was published, were made available to the public;

AND WHEREAS the copies of the said Gazette were made available to the public on the 4<sup>th</sup> July 2006.

AND WHEREAS, No objection and suggestion has been received on the said draft rules.

NOW, THEREFORE, in exercise of the powers conferred by Section 211 of Motor Vehicles Act, 1988 (Central Act 59 of 1988) and as amended by Act No.54 of 1994, the Administrator of Daman & Diu is pleased amend the Daman & Diu Motor Vehicles, 1989 as follows :-

1. Short title and commencement : (1) These Rules may be called the Daman & Diu Motor Vehicles (1<sup>st</sup> Amendment) Rules, 2006.
2. They shall come into force at once.

2. *Amendment of Rules 315 :-* Rule 315 shall be substituted as below :-

315. For assignment of a registration mark for a vehicle of the choice of the applicant, the following fees shall be levied as per the terms & conditions mentioned below :-

1.	Non-Transport Vehicles	0001 to 0009	Rs. 30,000/-
2.	Non-Transport Vehicles	0010 to 0025	Rs. 20,000/-
3.	Non-Transport Vehicles	0026 to 0100	Rs. 15,000/-
4.	Non-Transport Vehicles except two wheelers	0111 to 3150	Rs. 10,000/-
5.	Two Wheelers	3151 to 9150	Rs. 2,500/-
6.	Transport Vehicles	9151 to 9999	Rs. 10,000/-

The registering authority may assign any of the above registration marks to the vehicles belonging to the Government or Semi-Government or Government Undertaking without levying fees prescribed above.
