#### Notification

**No. Misc./Shops/2001/20104.**—In exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishment Act, 1958 (Punjab Act 15 of 1958) read with rule 15 of the rules framed under the said Act and all other powers enabling me in this behalf, the undersigned hereby exempt M/s. American Express Travel Related Services Enkay Centre A, A1 and A2, Udyog Vihar, Phase-V, Gurgaon from the operation of Section 30 of the Punjab Shops and Commercial Establishment Act, 1958 for a period of one year subject to the following conditions namely.

1. Management will provide adequate security and proper transport facility to the women workers;
2. the total number of hours of work in the establishment shall not exceed ten on any one day;
3. the spread over inclusive of interval for rest in the establishment shall not exceed twelve hours on any one day;
4. the total number of hours of over time work shall not exceed sixty in any one quarter and the person employed for over time work shall be paid remuneration at double the rate of normal wages payable to him calculated by the hours.
