

ANIMAL HUSBANDRY DEPARTMENT

Notification

The 12th/13th January, 2000

No. 180-AH-1-2000/538.—The Governor of Haryana hereby constitutes the Haryana Livestock Development Board with immediate effect to promote breeding and development of livestock specially cattle and buffaloes in the State by undertaking activities relating to and necessary for improving livestock production and productivity.

The objectives of the Board will be:-

- (i) to improve the genetic stock of animals in the State.
- (ii) to preserve and multiply the 'Murrah' germplasm and also take adequate steps to export it.
- (iii) to assist the farmers in providing technical know-how for improving the stock, and to assist them by providing artificial insemination and embryo transfer technology and other allied breeding facilities.
- (iv) to promote, organise and nurture institutions outside the Government to generate quality breeding inputs and for delivery of breeding services at the farmers' door-step on progressively self-generating and economically viable basis.
- (v) to Modernise and upgrade existing training facilities, establish new training facilities where necessary and set in motion a comprehensive human resources development programme, enhancing skills and professional competence at all levels on a regular and continuing basis.
- (vi) to establish collaboration and network arrangements with institutions of repute within the country as well as overseas to obtain newer technologies and to upgrade skills, on all aspects of livestock production, livestock products, product processing, storage, transport and merchandising and also to collaborate in research work and setting up joint ventures and joint projects in the area of livestock development.
- (vii) to arrange loans from the banks directly to the farmers as well as private entrepreneurs to achieve its objectives.

COMPOSITION OF THE BOARD

2. The composition of the Board will be as under:-
 1. The Secretary to the Government Haryana, Animal Husbandry Department. (*Ex officio*) Chairman
 2. The Director, Animal Husbandry Department, Haryana (*Ex officio*) Member Secretary
 - 3-4. Deans, College of Veterinary Sciences and College of Animal Sciences, Choudhry Charan Singh Haryana Agricultural University, Hisar. Members
 - 5-6. Two Chief Executive Officers of District Rural Development Agencies from the Districts in the State, to be nominated by the Government. Members
 - 7-8. Two Experts of the Department of Animal Husbandry, Haryana from the fields of Animal Breeding and Gynecology and Obstetrics to be nominated by the Government. Members
 9. One nominee of the Department of Animal Husbandry and Dairying, Government of India, New Delhi not below the rank of Joint Commissioner (Animal Husbandry) Member
 10. One representative of Finance Department, Haryana not below the rank of Joint Secretary (Finance) Member
3. The area of operation of the Board shall be the entire territory of the State of Haryana.
4. The Headquarter of the Board will be at Chandigarh and it may meet as often as may be necessary but at least twice a year.
5. The quorum of the meeting of the Board shall be three members in addition to the Chairman.
6. In case any vacancy arising in the Board, it may be filled up by the Government of Haryana in consultation with the Chairman of the Board.
7. Duration of the Board shall be three years.
8. The officers of the Board shall be the Chairman, Member-Secretary, Treasurer and any other officer designated as such by the Board.
9. Under the general supervision of the Board, an Executive Committee will be delegated the requisite administrative and financial powers for the formulation and

implementation of various activities of the Board. The Executive Committee will consist of the Chairman and Secretary of the Board alongwith five other officers to be nominated by the Board.

10. Suitable funds will be allocated by the Government to the Board. The Board will generate its own resources by proper management of its assets and by providing consultancy and marketing of its products including frozen semen. If the Board has surplus funds, it may assist the Department of Animal Husbandry in its strengthening and modernisation programmes.

11. The official members of the Board/Executive Committee/Sub Committee will draw their travelling allowance from their respective Departments. The travelling allowance to non-official members will be paid by the Board.

12. The following fixed assets will be transferred to the Haryana Livestock Development Board:-

1. Government Livestock Farm, Sector-I, Hisar alongwith all assets like land, livestock, farm machinery and Mechanical Workshop.
2. Government Livestock Farm, Sector-II, Hisar including land, livestock, farm machinery and Embryo Transfer Technology Laboratory.
3. Government Livestock Farm, Sector-III (State Cattle Breeding Project and Seed Farm) including semen bank, land, livestock, farm machinery and other equipments.
4. Model Exotic Animal Farm, Bhiwani with all assets (land, livestock, machinery etc.)
5. 10 semen banks in the State and 11 liquid nitrogen plants as under:
