No. 26/2/95-3MIP.—In exercise of powers conferred by Section 12 of the Punjab Electricity (Duty) Act, 1958 as applicable to State of Haryana and all other powers enabling him in this behalf, the Governor of Haryana is pleased to order the following amendments with effect from 15th November, 1995, in the Haryana Government, Irrigation and Power Department, Notification No. 26/2/93-3MI&P, dated 31st January, 1994.

AMENDMENT

In the Haryana Government, Irrigation and Power Department, Notification No. 26/2/93-3MI&P, dated 31st January, 1994 for the existing schedule, the following schedule of negative list shall be substituted, namely:—

No.	Name of the Industrial Units under Negative List
1	Oil Expellers (including RIS).
2	Dal Mills and Rice Mills (including RIS).
3	Steel and Wooden Furniture.
4	Stone Crushers (including RIS).
5	Power Cables except SLP Cables and Fibre Optic Cables.
6	Paraffin wax based industries excluding colorinated paraffin wax and the industry where the Paraffin wax is required in nominal quantity i.e. only upto 5% of the total raw material consumed by the unit.
7	Corrugation of G.P./P.B. sheets.
8	Caustic soda units except those based on membrane cell technology.
9	Simple fabricated items like trunks, buckets, gamlas windows, grills, trussess etc.
10	Ethanol (Ethyl Alcohol) based industries except non-mollasses alcohol industries.
11	Khandsari Units.
12	Bricks made of ordinary earth including mechanised bricks where the ordinary earth content is more than 50%.
13	Thinners.
14	Induction and ARC furnace with more than 0.5 MT capacity.
15	AAC/ACSR conductors.
16	L. P. Gas cylinders.
17	Non-graded CI casting.
18	Roller Flour Mills.
19	Re-rolling mild steel (re-rolling of special steel like EN-42 is not covered under the negative list).
20	Cotton Ginning and Pressing (including RIS).
21	All servicing units not providing service directly to the industry for production.

- 22 Soft drinks (Aerated water).
- 23 Asbestos products.
- 24 Distillery/Breweries.
- 25 Solvent extraction plants.
- 26 Oil Refinery (edible and non-edible).
- 27 Vegetable ghee.
- 28 Ice plants (including cold storage).
- 29 17 Highly polluting Industries, namely Fertilizer (Nitrogen Phosphate) Sugar, Cement, Fermentation and distillery, aluminium, petrol-chemicals, thermal power, oil refinery, sulphuric acid, tanneries, copper smelter, zinc smelter, iron and steel, pulp and paper, dye and dye intermediates, pesticides manufacturing and formulation and basic drugs and pharmaceuticals.
- 30 Cotton Spinning mill (except Hisar and Sirsa Districts).

Note :—

This amendment will not apply to the Industrial Units (i) which were established and got electric connection before 15th November, 1995; and (ii) which have already been granted exemption from the payment of the whole of electricity duty leviable under clause (iii) of the sub-section (i) of section 3 of the Punjab Electricity (Duty) Act, 1958 as applicable to State of Haryana under the said notification No. 26/2/93-3MIP, dated 31st January, 1994.
