

The following Act of the Tamil Nadu Legislative Assembly received the assent of the Governor on the 17th June 2022 and is hereby published for general information:—

ACT No. 37 OF 2022.

***An Act further to amend the Tamil Nadu Infrastructure Development Act, 2012.***

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Seventy-third Year of the Republic of India as follows:—

In section 3 of the Tamil Nadu Infrastructure Development Act, 2012 (hereinafter referred to as the principal Act), in sub-section (3), for clauses (c) to (m), the following clauses shall be substituted, namely:—</p> <p>“(c) the Chief Secretary to Government, <i>Ex-officio</i>;</p> <p>(d) the Secretary to Government, Finance Department, who shall be the Member–Secretary, <i>Ex-officio</i>; and</p> <p>(e) the Chief Executive Officer of the Board, <i>Ex-officio</i>.”.</p> | Amendment of section 3.       |
| Tamil Nadu Act 22 of 2012. | <p>3. In section 6 of the principal Act,-</p> <p>(1) for sub-section (1), the following sub-section shall be substituted, namely:-</p> <p>“(1) There shall be a Chief Executive Officer for the Board appointed by the Government.”;</p> <p>(2) in sub-section (2), the expression “with the approval of the Government” shall be omitted.</p>   | Amendment of section 6.       |
| Tamil Nadu Act 22 of 2012. | <p>4. In section 9 of the principal Act, in sub-section (2), for clauses (c) to (l), the following clauses shall be substituted, namely:-</p> <p>“(c) the Chief Executive Officer of the Board, who shall be the Member–Secretary, <i>Ex-officio</i>; and</p> <p>(d) experts in the fields of finance, economics, infrastructure and the like not exceeding two, as may be nominated by the Chairperson of the Executive Committee.”.</p>  | Amendment of section 9.       |
| Tamil Nadu Act 22 of 2012. | <p>5. In section 15 of the principal Act, sub-section (2) shall be omitted.</p>  | Amendment of section 15.      |
