S.O.154 .-In exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 (Central Act No. 29 of 1986) read with notification no. 1(38)86-PL dated 10-02-1988 issued by Department of Environment, Forests & Wildlife in the Ministry of Environment & Forests (MOEF), Government of India, the State Government hereby directs all District Collectors and Managing Directors/Chief Executive Officers/Plant Heads of all Thermal Power Stations in Rajasthan who have existing unutilized stocks of fly ash, in their ash ponds, to ensure that appropriate mechanism is put in place by them to supply fly ash, in accordance with the MOEF notification No.S.O.763(E) dated 14-09-1999, as amended from time to time, to the brick manufacturers who require fly ash for the manufacture of bricks and no impediments are put in their Way and no charges are levied or recoverd from them for this purpose.
