Whereas the draft of the following rules further to amend the Karnataka Agricultural Produce Marketing (Regulation and Development) Rules, 1968 which the Government of Karnataka proposes to make in exercise of the powers conferred by section 146 of the Karnataka Agricultural Produce Marketing (Regulation and Development) Act, 1966 (Karnataka Act 27 of 1966) was published as required by sub-section (1) of the said section in notification No: SAE/116/MRE/2016, dated: 17.09.2016 in part-IV-A in Karnataka Special Gazette dated: 20th day of September 2016 inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of its publication in the official Gazette.

And whereas the said Gazette was made available to the public on dated: 20th day September 2016.

And whereas, no objections or suggestions have been received in respect of the said draft by the State Government;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 146 of the Karnataka Agricultural Produce Marketing (Regulation and Development) Act, 1966 (Karnataka Act 27 of 1966) the Government of Karnataka hereby makes the following rules namely:-

RULES

1. Title and Commencement.-(1) These rules may be called Karnataka Agricultural Produce Marketing (Regulation and Development) (Amendment) Rules, 2016.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 87-C.- In the Karnataka Agricultural Produce Marketing (Regulation and Development) Rules, 1968, in Rule 87-C, in sub-rule(5), the following shall be substituted, namely:-

“(5) The applicant shall deposit an irrevocable bank guarantee of rupees Five Lakhs with the Director of Agricultural Marketing:

Provided that the bank guarantee specified under this rule shall be fifty percent to the Government organizations and Co-operative institutions.”
