NOTIFICATION

New Delhi, the 23rd April, 1993

G.S.R. 391(E).—In exercise of the powers conferred by section 23 of the Public Liability Insurance Act, 1991, (6 of 1991) the Central Government hereby makes the following rules further to amend the Public Liability Insurance Rules, 1991, namely :

1. (1) The Rules may be called the Public Liability Insurance (Amendment) Rules, 1993.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Public Liability Insurance Rules, 1991,—

(a) in rule 2, in clause (d), for the words “Fund” means a fund established”, the words “Fund means the Public Liability Insurance Fund established” shall be substituted.

(b) in rule 6, for sub-rule (1) the following sub-rule shall be substituted namely :—

“(1) An owner seeking exemption under sub-section (3) of section 4 of the Act, shall with the prior approval of the Central Government create and maintain a Fund for an amount of Rs. 5 crores or for an amount equal to the paid up capital of the undertaking

handling hazardous substances, whichever is less, in the State Bank of India or any of its subsidiaries or any nationalised Bank, and which will be available readily for meeting the liability of that owner under the Act".

(c) in rule 10, after sub-rule (3), the following sub-rule shall be inserted, namely :—

"(4) Notwithstanding anything contained in sub-rule (3), where an owner is exempted under sub-section (3) of section 4 of the Act, he shall be liable to discharge all the claims arising out of an accident."

(d) in rule 11, in sub-rule (1) for the words "An owner shall contribute", the words "An owner unless exempted under sub-section (3) of section 4 of the Act shall contribute" shall be substituted.
