The Municipal Corporation, Chandigarh in exercise of the powers conferred under Section 399 of the Punjab Municipal Corporation Act, 1976 as extended to the Union Territory, Chandigarh by the Punjab Municipal corporation Law (Extension to Chandigarh) Act, 1994 (Act No. 45 of 1994), intends to amend the Chandigarh Water Supply Bye-Laws 2011 as amended from time to time and as in accordance with the provision of sub-section (1) of Section 401 of the Punjab Municipal Corporation (as extended to UT Chandigarh) Act, 1994, read with sub section (2) of section 7A of the Capital of Punjab (Development & Regulation) Act, 1952, the Administrator UT Chandigarh after according approval to the same propose to issue the draft of notification which is hereby published for information of the persons likely to be affected thereby.

Notice is hereby given that the draft notification will be taken into consideration, on or after the expiry of period of 15 days from the date of publication of this notification in the official Gazette, together with any objection or suggestion which may be received by the Commissioner Municipal Corporation, Chandigarh, from any person before the expiry of the period, so specified, with respect to the draft namely:-

Draft BYE-LAWS

Short Title:-

These Bye-laws may be called the Chandigarh Water Supply Bye-laws, Amendment 2018.

These shall come into force from the date of its publication in official gazette.

In the Chandigarh Water Supply Bye-Laws 2011 as amended in 2016 (hereinafter referred to as said bye laws) for clause 10 the following shall be substituted as under:

Clause No. 10: Connection Pipe leakage of water line between ferrule to water meter:-

On observing leakage on such points, notice will be served to the consumer asking him/her to get the leakage rectified within a period of 2 days. In case of non compliance, leakage shall be got repaired at the risk and cost of the consumer and the amount so involved will be intimated to the water bill section along with the fine of Rs. 100/- which will be recovered in the ensuing water bill.

The cost of replacement of the damaged and leaking pipes shall be charged at the following rates:

1) Rs. 2,000/- (including cost of material and labour) If the Municipal line exists on the road berm

(i) 7% increase per annum w.e.f (1<sup>st</sup> day of succeeding month after issuance of notification)

(ii) Extra cost of road cut to be paid by the consumer as per actual site to the road department.

In the said bye laws, for clause 45(i), the following shall be substituted as under:

• No. 45 (i) The Municipal Corporation, Chandigarh, shall charge the following amount from the owners of the premises within its municipal limits who install tubewells in their premises after obtaining sanction from the competent authority:

Size of Bore of Tubewell	Amount
50mm (2")	Rs. 1500/- Per Month
65mm (2-1/2")	Rs. 22000/- Per Month
80mm (3")	Rs. 25000/- Per Month
100mm (4")	Rs. 35000/- Per Month
120mm (5")	Rs. 45000/- Per Month
150mm (6")	Rs. 50000/- Per Month
Above 150mm (above 6")	Rs. 60000/- Per Month

Note: (i) If bore of tubewell installed at premises found higher side from the approved size, the rate will be charged on penal rate i.e. double of actual bore size till the size will be got revised from the competent authority.

6. In the said bye laws, for clause 45(iv), the following shall be substituted as under:

(i) If the vehicles service stations are afforded another opportunity to install shallow tubewell within 3 months of issuance of notification, failing which a penalty of Rs. 2.00 lac will be imposed as one day and thereafter Rs. 5000/- per day will be charged till approval of installation of the Shallow tubewell in their premises.

(ii) All premises where tubewells have been sanctioned for potable water shall get water sample tested for chemical and bacteriological at least once in a month from the water works Sector 39, Chandigarh in public interest.

7. In the said bye laws, for clause 47, the following shall be substituted as under:-

(i) Direct on line water boosting arrangement shall be installed by the consumer. In case, it is found to be installed on the direct water supply system within the premises, the following action shall be taken against the consumer:-

(a) Confiscation of pump/motor for first offence with a fine of Rs. 5000/-

(b) Confiscation of pump/motor with disconnection of water connection with fine for second and subsequent offences:- Rs. 10000/-

8. In the said bye laws, for clause 51, the following shall be substituted as under:-

Clause 51:- Sewer connection charges for release of sewerage connection for the newly constructed buildings; for flats constructed by Chandigarh Housing Board

Sr. No.	Description of Buildings	Rates for new sewerage connection
1.	Flats having covered area upto 500 square feet	Rs.1000/-
2.	Flats having covered area above 500 square feet upto 1000 square feet	Rs.2000/-
3.	Flats having covered area above 1000 Square feet	Rs.4000/-

There will be no sewerage connection charges for the dwelling units allotted under rehabilitation scheme for slum dwellers)

In Marla Houses

1.	Upto 10 Marla House (250 Square yards)	Rs.2000/-

1.	Above 10 marla house (250 Square yards)	Rs.4000/-
3.	Houses above 1 Kanal (500 Square yards)	Rs.10000/-

Four times the rate of each category to be levied upon on regularization of illegal sewer connection.

Waste Cess within the Municipal limits of Chandigarh Municipal Corporation shall be charged at the following rates:

1.	Residential Building :-	30% of water consumption
2.	Hotels/Commercial Premises, Institutions and other categories:-	30% of water consumption

Reference your note dated 23.12.2015, on the subject  
noted above.

2. It is informed that on combined reading of provisions of  
Byelaw No.5,6, 13(xiii) of the Chandigarh Water Supply Byelaws  
2011, it is crystal clear that there is no bar in granting water  
connections and these can be granted to Booths/SCOs/SCF/Bay  
shops (water consuming business or running trade of fast  
food/dhabas as well as general trade). As the provision already exist  
in the Byelaws for grant of water connection in the Chandigarh Water  
Supply byelaws, 2011, no amendment therein is required for the  
grant of water connection Municipal Corporation Chandigarh is only  
required to dispose of the requests in the light of byelaws and  
Chandigarh Administration's orders dated 25.06.2002 modified vide  
orders dated 24.02.2006, and allow water/sewerage connection  
without any riders. However, Municipal Corporation Chandigarh  
authorities will have to carry out their checks regularly and take  
action against those not abiding by these. You are therefore  
requested to take further action at your end accordingly

Whereas, the Chandigarh Water Supply Bye Laws -2011 notified vide no. 6/1/195-FII(8)-2011/4088 dated 24<sup>th</sup> May, 2011 and further amended vide no. 6/1/195-FII(8)-2016/4058 dated 03.05.2016 and now recommendations have been received on the approval of General House of Municipal Corporation, Chandigarh that the illegal water connections in all colonies and villages falls under Municipal Corporation, Chandigarh be regularized as a onetime measures.

Now in the exercise of powers conferred upon him under sub section (1) of Section 401 of Punjab Municipal Corporation Act, 1976 as extended to the union Territory, Chandigarh by the Punjab Municipal Corporation Law (Extension to Chandigarh) Act, 1994 (Act No.45 of 1994), the Administrator, Union Territory, Chandigarh hereby regularize the illegal water connections in all colonies and villages falling under the jurisdiction of Municipal Corporation, Chandigarh as a onetime measures valid for 3 months from the issue of this order on the following rates and conditions:-

1.	Before 31 <sup>st</sup> May, 2011, and thereafter as per Sr.No.2 below	Rs.50/- per month	Rs.400/- Per month
2	After 1 <sup>st</sup> June, 2011 upto 31.07.2018 and thereafter as per Sr. No.3 below	Rs.200/- per month	Rs.800/- Per month
3	After 1 <sup>st</sup> August, 2018	As per applicable Chandigarh Water Supply Bye Laws, 2011	

**Note:**

1. The construction charges as applicable will be charged separately.
2. The consumer to deposit onetime charges as above within 90 days from the date of official order from competent authority.
3. If the consumer deposits one-time charges within 90 days from the date of issue of this official order, a rebate of 10% will be given to consumer.
4. If the consumer fails to deposit the same within 90 days from the date of issue of this official order, the illegal connections thereafter will be disconnected and no relief of this order is admissible.
5. The consumer shall require to furnish an undertaking as to nothing is due against the premises. The objective of the said regularization is to provide basic amenity i.e. water to the residents of area under the jurisdiction of M.C, Chandigarh only. It is to note that mere regularization of the connection shall not be construed a legal right, for any other purpose.

This order issues with the approval of H.E., The Administrator, U.T., Chandigarh as conveyed vide Local Government Department, Chandigarh Administration, Chandigarh vide No.1802-FII (8)-2016/21487 dated 22.11.2018.
