NOTIFICATION

No. 1417-L.—27th August, 2003.—The following Act of the West Bengal Legislature, having been assented to by the Governor, is hereby published for general information :—

**West Bengal Act XXII of 2003****THE WEST BENGAL STATE HEALTH SERVICE****(AMENDMENT) ACT, 2003.***[Passed by the West Bengal Legislature.]**[Assent of the Governor was first published in the Kolkata Gazette, Extraordinary, of the 27th August, 2003.]**An Act to amend the West Bengal State Health Service Act, 1990.*

WHEREAS it is expedient to amend the West Bengal State Health Service Act, 1990, for the purposes and in the manner hereinafter appearing;

West Ben.

It is hereby enacted in the Fifty-fourth Year of the Republic of India, by the Legislature of West Bengal, as follows :—

Short title and  
commencement.

1. (1) This Act may be called the West Bengal State Health Service (Amendment) Act, 2003.

(2) It shall come into force at once.

Amendment of  
section 6 of West  
Ben. Act VII of  
1990.

2. In sub-section (2) of section 6 of the West Bengal State Health Service Act, 1990 (hereinafter referred to as the principal Act), after the third proviso, the following proviso shall be added :—

“Provided also that it shall be the duty of a person, holding teaching post in any of the non-practising institutions as laid down in sub-section (1), to render, in addition to his own duties, patient care services in the Poly Clinics or Pay Clinics run in such non-practising institutions.”

Amendment of  
section 14.

3. In section 14 of the principal Act,—

(1) in sub-section (1), in clause (a) of the second proviso, for the words “eleven years”, the words “fifteen years” shall be substituted;

(2) in sub-section (2A), in the second proviso, for the figures, letters and words “24th day of May, 2001.”, the figures, letters and words “24th day of May, 2005.” shall be substituted.

Amendment of  
section 19A.

4. In the proviso to section 19A of the principal Act, for the words “eleven years”, the words “fifteen years” shall be substituted.

Amendment of  
section 22.

5. In the proviso to section 22 of the principal Act, for the words “eleven years”, the words “fifteen years” shall be substituted.

Saving and  
validation.

6. Anything done or any action taken under the principal Act as amended by this Act before the publication of this Act in the *Official Gazette* shall be deemed to have been validly done or taken under the principal Act as amended by this Act as if this Act were in force when such thing was done or such action was taken.
